REPRESENTATIVE PLAYER CONTRACT 2021

1. I am aware and agree that the annual cost for playing Representative Netball is a minimum of \$100. This must be paid on or before the commencement of the Season. This is separate to my FNA membership fees.
2. All correspondence between the Player, Parents and FNA must be in writing and directed to the Representative Convenor. Correspondence may be emailed to fassifernnetball@hotmail.com All dealings between players, parents and Rep convenor are in confidence unless otherwise stated.
3. I will attend and be on time for all weekly training sessions, the day to be determined by my coach and manager.
4. I will arrive 10 minutes prior to training and be ready to start on time.
5. I will arrive 30 minutes prior to the start of any game and warm up appropriately.
6. If I am unable to attend any of these sessions I will notify my coach at least 24 hours prior to the session, to enable my coach to make other arrangements if necessary.
7. If I am unable to attend any of the Carnivals or Championships I will inform my team manager and coach at least one month in advance. If I am unable to attend due to illness, I will inform officials of this fact immediately.
8. At carnivals and championships, the Coach appointed by the FNA is the sole selector of the team to play in each match. This can at times be based on skills not equal play.
9. I agree to participate in **ALL** fundraising activities organised by the association to help support the costs associated with Representative netball.
10. I agree to pay for the cost of my tracksuit jacket (if required), approx. cost \$45.
11. I agree to keep and maintain my Rep Dress to a high standard ensuring that it is returned in the same condition I received it. Fair ware and tare accepted.
12. I will play in a competitive, safe and sportsmanlike manner.
13. I will show respect at all times for my team mates, for Fassifern Netball officials and players as well as all officials, parents and players from other associations.
14. I agree to travel with my team by bus where a bus has been provided by FNA, or private transport as organized by team officials or the Rep committee.
15. Each year the FNA determines the format of the competition and the make-up of the teams for the Monday night club competition. If FNA permits, I agree to play with a Rep team on a Monday night in a division determined by the FNA executive.
16. I agree to take part in recovery regimes as directed by my coach.
17. I agree to assist with the packing up of equipment at the end of training or games.
18. I agree to sit the umpire's theory exam when required if I haven't already passed one in the last 12 months.
19. The coach, team officials or Rep committee will determine consequences in relation to breaking any of the above guidelines.
